# AWARD STATEMENT ASSOCIATION «FINANCIAL & BUSINESS ASSOCIATION EURO-ASIAN COOPERATION» (FBA EAC)

#### 1. GENERAL PROVISIONS

- 1.1 The Award Statement (later Statement) is worked out for definition of rewarding individuals and legal entities, organizations and legal entities, organizations and institutions members and partners Association "Financial & Business Association of Euro-Asian Cooperation" (later the Association).
- 1.2 The Statement is worked out in accordance with the Statute FBA EAC.
- 1.3 The Statement defines types of awards of the Association, status and description of awards, regulates award order and award procedure.
- 1.4 Awards of the Association are recognition form for merits of persons and organizations, which make a significant contribution in development of different economy spheres and statutory activity of the Association.
- 1.5 Awards of the Association are:
  - Badge of Honor FBA EAC Order;
  - Badge of Honor FBA EAC;
  - Diploma;
  - Golden Badge FBA EAC;
  - Silver Badge FBA EAC.
- 1.6 Examples of Badges of Honor, Diploma, Distinctive signs and shown in them information are approval by Executive Board of the Association.
- 1.7 Receiving awards of the Association, at the discretion of direction of person to be awarded, may give reason to application of additional encouragement measures to him. These measures should be provided by the inner rules of the organization or by collective agreement (receiving bonus, receiving valuable gift, salary increase, promotion or other).

#### 2. AWARD ORDER OF THE ASSOCIATION

- 2.1 Intercession for each candidate of the Association award should be filled (besides award Silver Badge FBA EAC). Intercession is filled in free form and should contain: type of award, reason of receiving award and motivated justification, included information about the merits of candidate.
- 2.2 Intercession is composed by the direction of organizations members of the Association and its partners. Intercession is submitted to review of Executive Board of the Association.
- 2.3 The right of nomination of candidates on receiving the awards have Executive Board, President, General Director, Supervisory Council and Business Council of the Association.
- 2.4 Received intercessions are considered by the members of Executive Board during 7 days from day of receiving. Consideration may be personal or remote.
- 2.5 Decision of Executive Board about rewarding is took by simply majority vote with quorum and drown up by the protocol.
- 2.6 Rewarding is produced sequentially: Diploma FBA EAC, Badge of Honor FBA EAC, Badge of Honor FBA EAC Order. In special cases and only based on decision of Executive Board rewarding of candidate is carried out out of order specified in this paragraph of the Statement.
- 2.7 **Silver Badge FBA EAC** is awarded to the partners of the Association, making the significant contribution in activity of the Association, realization of joint projects and developing private business on the territory of Euro-Asia.
- 2.8 **Golden Badge FBA EAC** is awarded to members FBA EAC simultaneously with Registry of members FBA EAC enter. It is the sign of affiliation to the Association.
- 2.9 **Diploma FBA EAC** is awarded for significant contribution to organization of effective business on the territory of Euro-Asian countries to members FBA EAC, leaders and employers of financial and banking and other business-structures, state and supranational government bodies, scientific and social organizations, presenters of mass media.
- 2.10 **Badge of Honor FBA EAC** is awarded to members and partners of the Association, directors and emploeers of financial&banking and other business structures, scientific and social organizations, state and supranational governmental bodies for special personal merits, high professionalism, active participation in the Association activity, contribution to deelopment of economies of Euro-Asian countries. Award presentation by Badge of Honor may be done not earlier than in a year from last receiving award FBA EAC.
- 2.11 **Badge of Honor FBA EAC Order** is the highest degree and assigned to outstanding personalities, directors of organizations members of the Association, activity of which is connected with solving problems on legislative, organizational, scientific & analytical and informational provision of developing financial & banking and real sectors of economy on the territory of Euro-Asia, for significant contribution in organization and augmentation economy potential of Euro-Asian countries, for significant contribution in realization of statutory aims of the Association. With the Badge of Honor Order are awarded standard certificate and fright badge.

#### 3. ORDER OF AWARD OF THE ASSOCIATION

- 3.1 Rewarding is made in a solemn atmosphere: in a day of Annual Session of members of the Association, on sessions of Executive Board or on public events, hold by the Association.
- 3.2 Award are given by Chairman of Executive Board, President of the Association, Chairman of Supervisory Council and Chairman of Business Council to rewarded personally or to his representative.
- 3.3 One person could not be rewarded by one award twice.
- 3.4 Award winning persons should ensure their safety. In case of lose rewarded save their rights for award. Secondary award marked in the Statement awards is not possible.

# 4. AWARD ACCOUNTING

4.1.1 Award and supplement documents accounting is lead by designated employer of the Association.

# 5. FINAL PROVISIONS

- 5.1 Decision about making additions or changes in the Statement is took by Executive Board of the Association.
- 5.2 Institution of awards and award abolition entails changes in the Statement.
