



On April 28, 2021, the extended meeting of the Board of the FBA EAC was held with the participation of members of the Supervisory and Business Councils of the Association. It was held in a video conference mode. **Alexander Murychev**, Chairman of the Board of the FBA EAC, chaired the meeting.

The participants discussed the role and place of the FBA EAC in building business communications during the deterioration of the epidemiological situation in the world, discussed the possibilities of interaction with the International Bank for Economic Cooperation, on the

basis of which the International Fund for Technological Development was formed, approved the project of the Committee on Industrial Policy and Engineering, which involves the development and creation of the Association's business platform-"FBA Portal".

Abdoulaye Sow, Member of the Board of the FBA EAC, President of the West African and Russian Industrial Group (WARIG)-with a high assessment of the Association's journal "Eurasian Financial and Economic Bulletin", which will be presented to the President of Senegal, Mr. Macky Sall, and distributed in Africa.
